The Pharmacy Department at KDHCD provides both inpatient and outpatient pharmacy services consisting of six licensed pharmacies and a Department of 100+ staff with over 55 pharmacists.

INPATIENT PHARMACY SERVICES

- Inpatient Pharmacy Services
 - Provides service at the 3 KDHCD acute care campuses
 - Main Medical Center, West Campus, South Campus
 - Medical Center Pharmacy operates 24/7
 - 80+ staff members
 - Employs extensive pharmacy-related technology to provide safe and efficient services
 - Teaching affiliation with Schools of Pharmacy, hosting an average of 50 pharmacy student rotations each year
 - American Society of Health-Systems Pharmacistsaccredited PGY1 Pharmacy Residency Program - 2 residents

OUTPATIENT PHARMACY SERVICES

- Outpatient Pharmacy Services
 - KD Home Infusion Pharmacy Location: 602 W. Willow
 Services offered include: antibiotic therapy, enteral and parenteral nutrition, hydration therapy, pain management, other injectable pharmaceuticals
 - <u>KD Outpatient Pharmacy</u> <u>Location</u>: 202 <u>Willow Building</u>, 1st floor
 Provides meds-to-beds prescription service for inpatients being discharged and
 community members at large.
 - KD Employee Pharmacy Location: 602 W. Willow Provides prescription services for KD employees and their families.
 - Ambulatory Care & Transition based Clinical Pharmacy Services

INPATIENT PHARMACIST SERVICES

- Clinical Pharmacist Team
 - Clinical Pharmacists are available on most nursing units
 - Participate in bedside rounds, code blue and rapid response team calls
 - Provide patient-specific and comprehensive drug information
 - · Highly trained, patient-centered
 - ~80% have completed at least 1 year of post-graduate residency training
 - ~40% are board certified as pharmacotherapy specialists or similar certification
 - Specialty Pharmacist Services are available as follows:

MEDICATION USE PROCESS

- Medication orders electronically entered in CPOE using P&T approved order sets
- All new medication orders are sent to Pharmacy via CPOE
 - Orders are processed in the order they are received except STAT orders are processed first
- All medication orders are reviewed and verified by a pharmacist
- Medications are made available for administration via:
 - Unit Based Cabinets (Pyxis) 97% of medications
 - From Central Pharmacy to Patient Care Area Medication Room via pneumatic tube system or courier
- Medication Administration is performed using bar code technology

COMPLETE MEDICATION ORDERS

- A complete medication order includes:
 - Drug name, dose, frequency, route and indication for PRN orders, date, time and prescriber signature/ID number
- The pharmacist will call the prescriber to clarify any order that is incomplete or unclear
- Examples:
 - Therapeutic duplication More than one pain medication for the same intensity of pain
 - Titration orders with no min/max/goal defined
 - Blanket order for "resume all" medications are prohibited

Transitions of Care for High Risk Patients	No specific order required - Verifies home medication list Reviews discharge medication list Education on high risk meds at discharge

AUTOMATIC CONSULT SERVICES

Automatic, per P&T approved medicaiton protocols

- Age-Specific Sedative Dose Reduction:
- Automatic dose reduction of bedtime sedative doses for patients <u>></u> 65 as a part of our fall prevention program
- Renal Dose Adjustment:
 - Automatic dose adjustment in pts with reduced renal clearance and/or age ≥ 60 in addition to daily review of renal function, ongoing monitoring and dose adjustment
- IV to PO switches:
 - Automatic IV to PO transition for select medications
- Automatic Therapeutic Interchanges:
 - Allows the pharmacist to automatically adjust medication orders based on formulary availability
